DEFINITIONS				
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. Your choices will apply to everyone on your account.			
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. The Bullion Advisory Group LLC does not share with non-affiliated companies so they can market their products to you.			
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. We only share information with non-Bullion Advisory Group affiliated companies to service transactions that you request.
